1. Purpose of the Report

- 1.1. To advise the Authority has a duty to review the current Gambling Act Statement of Principles in relation to the Gambling Act 2005.
- 1.2. To bring before the Licensing Committee the outcome of the approved consultation exercise for the Council's draft Gambling Statement of Principles. The public consultation exercise concluded on 4th November 2024.

2. Executive Summary

2.1. In accordance with the requirements of the Gambling Act 2005 the Licensing Authority is required to publish a statement of policy every successive three year period from the first appointed day. The policy is now due to be revised to cover the next successive three year period until 2028.

3. Background

3.1. Section 349 of the Gambling Act 2005 ("the Act") requires all Licensing Authorities to prepare and publish a Statement of Principles in the form of the Gambling Policy ("the Policy") that it proposes to apply in exercising its functions under the Act during the three year period to which the Policy applies.

- 3.2. The Council's Policy has been revised on a three yearly basis since then and it is time to revise the Policy to cover the next three years' to cover February 2025 to February 2028.
- 3.3. The Council has consulted for 28 days on the proposed changes. This concluded on 4th November 2024.
- 3.4. The Licensing Committee approved the draft policy as suitable for consultation purposes and are now required to review any comments received during the consultation period prior to Full Council for adoption.

4. Contribution to Corporate Priorities

4.1. Creating a prosperous East Staffordshire

5. Report

- 5.1. The Gambling Act 2005 was fully implemented on 1st September 2007. The Act introduced new responsibilities for Licensing Authorities, to undertake a number of licensing functions in relation to gambling premises.
- 5.2. Section 349 of the Gambling Act 2005 requires the Council (The Licensing Authority) to prepare and publish a Gambling Act Policy "Statement of Principles" that it proposes to apply in exercising its licensing functions. The statement will last for a maximum of three years but can be reviewed and revised by the Authority at any time. The Authority's current statement was published in 2022.
- 5.3. The Act provides for three categories of licence:
 - Operating licences
 - · Personal licences; and
 - · Premises licences.
- 5.4. The Gambling Commission issues Operating licences and Personal licences and Licensing Authorities issue Premises Licences.
- 5.5. The Gambling Act 2005 places a responsibility for the licensing of gambling premises and the issuing of permits with Local Authorities, with associated responsibility of ensuring that the conditions on these licences are upheld. Amongst other matters the 2005 Act deals with the licensing of:
 - Casinos
 - Betting shops
 - Bingo halls
 - · Amusement arcades and gaming centres
 - Gaming machines
 - Small Society Lotteries
 - Alcohol licensed premises (making gaming machines available for use)

- Private clubs (making gaming machines available for use).
- 5.6. Central to the Gambling Act are the licensing objectives. These are:
 - Preventing gambling from being a source of crime and disorder, being associated with crime and disorder or being used to support crime,
 - Ensuring that gambling is conducted in a fair and open manner,
 - Protecting children and other vulnerable persons from being harmed or exploited by gambling.
- 5.7. It is important to note that there are no other licensing objectives.
- 5.8. Section 349 (3) of the Act requires the Licensing Authority to consult the following on its licensing policy statement or subsequent revision:
 - · The Chief Officer of Police,
 - One or more persons who appear to the Licensing Authority to represent the interests of persons carrying on gambling businesses in the Authorities area; and
 - One or more persons who appear to the Authority to represent the interests of persons who are likely to be affected by the exercise of the Authorities functions under the Act.
- 5.9. The list of persons to be consulted when preparing the Licensing Policy Statement is deliberately wide. This enables Licensing Authorities to undertake a comprehensive exercise with anyone who may be affected by or otherwise have interest in the Licensing Statement.
- 5.10. Section 154 of the 2005 Act indicates that adoption of the Statement (Gambling Policy) cannot be delegated to the Licensing Committee. Therefore, Full Council must adopt the final document.
- 5.11. The first draft of the proposed revised policy is attached as Appendix 1. The policy has been amended in accordance with the guidance issued by the Gambling Commission.
- 5.12. Appendix 2 details a matrix of changes within the policy. The changes are:
 - o Update to the ESBC population
 - o Potential future for cumulative impact assessment
 - Voluntary changes to the Gambling Commissions requirements of small society lotteries.

5.13. The current policy was published in 2022 and therefore a reviewed policy will need to be published in 2025.

Consultation Responses

- 5.14. Three responses were received to the consultation. These detailed at Appendix
- 5.15. 2 Acknowledgement emails were received from Burton Parish Council and Dunstall Parish Council.
- 5.16. A third response was received from Gamcare. They raise the following points:
 - We welcome the position East Staffordshire Council is taking to go beyond the mandatory and default conditions of the Gambling Act 2005 in its statement of principles.
 - Local authorities can play a greater role in reducing gambling harm, particularly for those of our clients who experience harm in land-based gambling venues, due to council's licensing responsibilities.
 - It is vital that East Staffordshire Council develops a local picture of the level of gambling harms, in order to best target resources and tailor service provision. This could be achieved by gathering data from the National Gambling Helpline, as well as those already providing services in the area.
 - Building on the proactive approach the council is already taking, we
 would like to see East Staffordshire Council commit in its statement of
 principles to a public health approach to gambling.
 - This commitment should include training frontline and primary care staff
 to recognise the signs of gambling harm and develop referral pathways
 to the National Gambling Helpline or local treatment providers.
 GamCare has worked with Haringey Council to implement a similar
 system, that has received widespread support.
 - In the absence of Cumulative Impact Assessments as a method by which the "aim to permit" approach can be challenged, East Staffordshire Council should continue to pursue a <u>Local Area Profile</u> approach that specifically analyses gambling risk, and use this data as a basis from which to scrutinise and possibly oppose a licensing application.
 - The changes to East Staffordshire Council's statement of principles should be viewed in the context of the Gambling Act Review and subsequent process of white paper consultations, so take account of the rapidly changing regulatory environment.

8. Legal Considerations

8.1. The Council is required to produce and publish a Statement of Licensing Policy under section 349 of the Gambling Act 2005, to cover each successive period of three years. Section 349(2) requires the Council to review the statement from time to time and if thought necessary as a result of the review, publish any revision before giving effect to it.

- 8.2. The Statement of Principles attached at Appendix 1 is the Council's statement for the purpose of section 349 of the Act.
- 8.3. In accordance with section 349(3), consultation must precede any revision of the Statement of Licensing Policy. The Council must also consult the following people for its area:
 - a) The chief officer of police;
 - b) People representing the interests of persons carrying on gambling businesses:
 - c) Persons who represent the interests of persons who are likely to be affected by the Council exercising its functions under the Act.
- 8.4. The Gambling Act 2005 (Licensing Authority Policy Statement)(England and Wales) Regulations supplement the 2005 Act. It is prescribed that before a statement or revision comes into effect, the Council must publish a notice of their intention to publish a statement or revision for a period of 4 weeks. The notice must:
 - Specify the date on which the statement or revision is to be published;
 - Specify the date on which the statement or revision will come into effect;
 - Specify the internet address where the statement or revision will be published and the address of the premises at which it may be inspected;
 - Be published on the authority's website and in/on one or more of the following places for at least four weeks before it comes into effect:
 - a local newspaper circulating in the area covered by the statement
 - a local newsletter, circular, or similar document circulating in the area covered by the statement
 - a public notice board in or near the principal office of the authority
 - a public notice board on the premises of public libraries in the area covered by the statement
- 8.5. As the policy forms part of the Council's Policy Framework, the Constitution prescribes that any final decision on the policy must be taken by Full Council. However Licensing Committee can be consulted as part of the process.
